## PRIVACY POLICIES

### Information Collected

SitesUSA, Inc. does not collect, store, use or disclose personally identifying information about common users browsing Our Website. It is necessary for Us to collect certain customer information to provide the Services available through our Website. This information includes first and last name, address, email address, telephone number and credit card information. We also collect location information necessary for the use of our Services. This may include acquiring information about Your location, Your address or information about locations You specify.

We do not intentionally collect personal information about children under the age of 18. If You are under the age of 18, You may use this Website and the Services only under the supervision of a parent or legal guardian who agrees to be bound by Our Terms of Service. If You do not agree to (or cannot comply with) any of the Terms of Service, do not use the Services or access the Website.

### Ways Information Is Collected

We may collect any or all of the following types of information:

Website data, cookies, contact information or other personally identifiable information and information you provide in connection with your use of the Services.

Explanations of the collection and use of each type of data and its use are described below.

(a) **Website Data.** Data about Website usage is not personally identifiable and is not supplemented or combined with personally identifying or identifiable information. We may share the information We collect with certain selected third parties, but only in aggregated, anonymous form. The data is generally used for completion and support of the current activity, Website Services and system administration, and research and development.

(b) **Cookies.** We assign cookies to You when You use the Services. These enable You to more efficiently use the Services. In addition, We collect cookies to assist in Your ease of use of the Website and the Services. Cookies are used to facilitate Your use of the Services.

(c) **Contact and Account Information and Information You Provide.** We collect Your name, address, email address, telephone number, and other contact information only when You submit such information. This information is used for administrative and billing purposes. This information is also used to enable and facilitate Your use of the Services and to provide You information concerning use of the Website and the Services. Also, certain information You provide will also be provided to our service providers and suppliers and the use and

disclosure of this information is necessary to allow You to use the Services. To the extent possible, We limit the disclosure of personally identifiable information only to the extent necessary to allow use of the Services. Personally identifiable information is provided to our service providers to allow You to use the Services.

We also collect location information about you which you provide. This information is voluntarily supplied by You in connection with your use of the Services. This information is only used to allow you to use the Service and used in connection with your use of the Services.

Your name, address, telephone number, credit card information and account information is maintained by Us as long as Your account is open and active, in order to allow Us to bill for the Services. When You close Your account, Your account information is deleted. Credit card information is used only for billing purposes and is not used for any other purpose. Credit card information will be provided to Our bank and credit card processors for purposes of processing credit card transactions on Your account.

## **Data Security**

We have appropriate security measures in place in Our physical facilities to protect against the loss, misuse or alteration of information that has been collected from You through the Website or Your use of the Services. We use industry-standard encryption technologies to protect Your information from unauthorized access. In addition, our web servers are housed in a secure location and we use industry standard measures to restrict access to those servers to only persons who have a need to have such access.

Although We take reasonable steps to safeguard and to prevent unauthorized access to Your private information, We cannot be responsible for the acts of those who gain unauthorized access, and We make no warranty We will prevent unauthorized access to Your private information.
